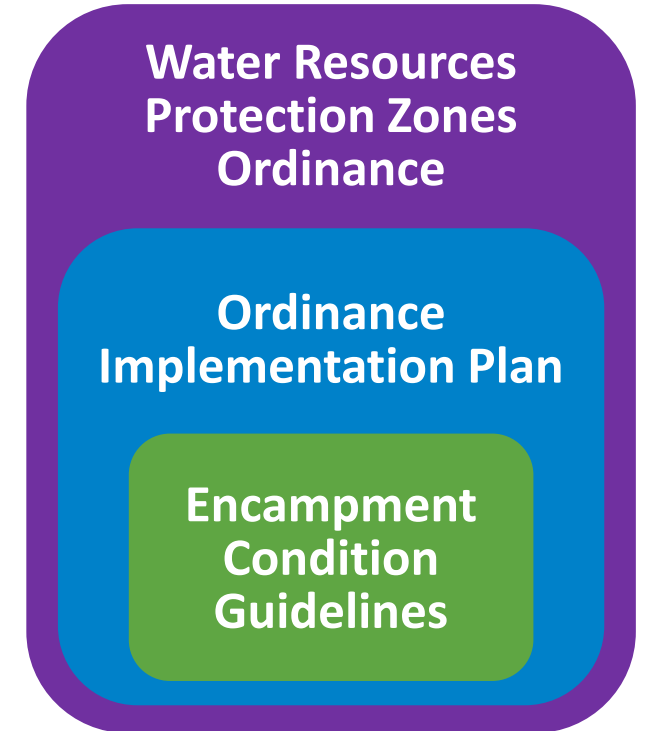

# WRPZ Ordinance – Overview

- **WRPZ Ordinance:** adopted by the Board on November 26, 2024; went into effect December 26, 2025
- **Ordinance Implementation Plan:** provides framework for how ordinance will be implemented
- **Encampment Condition Guidelines:** provide guidance for unsheltered individuals to be considered low priority for enforcement
  - **High Priority** – immediate enforcement for severe environmental, health, or safety risk or obstructing Valley Water projects
  - **Low Priority** – comply with safe and sanitary camping practices



# WRPZ Ordinance – Implementation Updates

- **Encampment Cleanup Operations:** no initial changes to operations as the education and outreach structure is being put in place
- **Early Education:** Valley Water field staff have begun to provide education to unsheltered individuals on Encampment Condition Guidelines
- **Progressive Enforcement Approach:** unsheltered individuals will receive education across multiple visits and have opportunities to self-remedy violations to stay low priority

### Water Resources Protection Zones Ordinance



#### OVERVIEW

Valley Water's Water Resources Protection Zones (WRPZ) Ordinance was adopted Nov. 26, 2024, to address the environmental, health, and safety impacts of encampments of unsheltered individuals living on Valley Water lands. The WRPZ Ordinance establishes [new regulations prohibiting camping and encampment-related activities on Valley Water lands](#) and outlines Valley Water's approach to encampment cleanup, removal, and enforcement related to violations of the regulations.

#### IMPLEMENTATION

The WRPZ Ordinance will enable Valley Water to better manage encampment impacts while continuing to work with local agencies and private partners to implement long-term solutions to address unsheltered homelessness within Santa Clara County. #### ENFORCEMENT PRIORITY LEVELS

Implementation of the ordinance uniformly across all Valley Water lands would displace unsheltered people from encampments before adequate safe relocation sites, shelter, and housing options are available in Santa Clara County. In consideration of this reality, Valley Water will establish priority levels for encampment cleanup and removal under the ordinance. See [reverse](#) for priority levels.

#### ENCAMPMENT CONDITION GUIDELINES

The Ordinance Implementation Plan includes Encampment Condition Guidelines that establish basic parameters by which unsheltered individuals living in encampments on Valley Water lands can minimize negative environmental, health, and safety impacts by promoting positive camping practices and discouraging harmful actions. Valley Water will monitor encampments to ensure that conditions are safe and sanitary. Observations or complaints will be addressed with the unsheltered individuals living in an encampment where complaints or observations occur.

#### PROGRESSIVE ENFORCEMENT

Encampments that do not create operations or maintenance access issues and that meet the Encampment Condition Guidelines will be considered low priority for cleanup and/or removal. Valley Water is committed to alternatives to enforcement that avoid citation and arrest wherever possible. Valley Water will strive to provide options to remedy violations through positive actions such as education.

**WATER RESOURCES PROTECTION ZONES ORDINANCE**

**PROHIBITED ACTIVITIES UNDER THE ORDINANCE\***

The ordinance prohibits camping within Water Resources Protection Zones, which encompass all lands where Valley Water owns property in fee title, has an easement or has maintenance obligations.

"Camping" is defined as unauthorized sleeping, erecting a shelter of any type, storing, using, maintaining, or placing personal property.

The WRPZ Ordinance also prohibits:

- Dumping trash, debris, and/or other hazardous pollutants
- Activities that could create a hazard to Valley Water employees or the public, or that could interfere with the safe operation of Valley Water facilities
- Unlawful activities, and possession of firearms, ammunition, or fireworks

#### EDUCATION AND OUTREACH

Valley Water staff will inform and educate unsheltered people living within Water Resources Protection Zones (WRPZ) on the ordinance and Encampment Condition Guidelines on a real-time, continual basis during encampment site visits.

#### ENFORCEMENT PRIORITY LEVELS

Valley Water will prioritize encampment cleanup and removal as necessary to protect employees and public safety and to carry out Valley Water business.

#### HIGH PRIORITY FOR ENFORCEMENT

An encampment will be prioritized as high priority for cleanup and removal under any of the following conditions.

- The encampment is located in the path of or obstructing access to flood protection or water infrastructure facilities or projects; or designated restoration or vegetation management sites.
- The encampment is located within an area with posted signage listing restrictions on camping or re-encamping.
- The encampment poses an immediate safety risk, including situations that involve Valley Water staff safety or public safety issues, as determined by government agencies and their police or fire departments.
- The encampment is associated with extreme environmental hazards, including impacts to fish and wildlife or imminent human health or fire hazards.

In addition, unauthorized motor vehicles and trailers located within a Water Resources Protection Zone will be classified as high priority for cleanup and removal.

#### LOW PRIORITY FOR ENFORCEMENT

Encampments that meet the Encampment Condition Guidelines and maintain an external footprint, including all belongings, of 12 feet by 12 feet or less and do not create operations or maintenance access issues.

#### ENCAMPMENT REMOVAL PROTOCOL

When cleanup and removal action is warranted, per the priority levels described above, Valley Water staff will follow an encampment removal protocol:

 Post the encampment for cleanup and removal.	 Provide 72 hours notice before cleanup and removal.
 Collaborate with local agencies for offers of available services and/or housing or shelter.	
 Arrange for processing and storage of personal belongings.	 Perform encampment cleanup and removal.

## Encampment Response Protocol



### WHAT IS AN ENCAMPMENT?

Valley Water's Water Resources Protection Zones Ordinance defines an encampment as one or more structures operating as a single entity, occupied by an individual or group of individuals, that is located illegally on Valley Water or other public property. An area where there are no structures, but where personal property is stored or where animals are kept and or maintained without authorization from Valley Water, is also considered an encampment.

### WHAT IS VALLEY WATER DOING TO ADDRESS ENCAMPMENTS?

Valley Water collaborates with local agencies, social service providers, and law enforcement officers to address the challenges posed by encampments located on Valley Water property and their impacts to waterways and water supply and flood protection facilities.

Valley Water's Water Resources Protection Zones Ordinance was adopted on Nov. 26, 2024, to address the environmental, health, and safety impacts of encampments. The ordinance established new regulations prohibiting encampments and encampment-related activities on Valley Water lands and outlining Valley Water's approach to encampment cleanup, removal, and enforcement related to violations of the regulations.

- Request that the individual(s) cease prohibited activity or activities.
- Request relocation of the encampment.
- Prioritize the encampment for cleanup and or removal.
- Request law enforcement involvement to address unlawful activities.

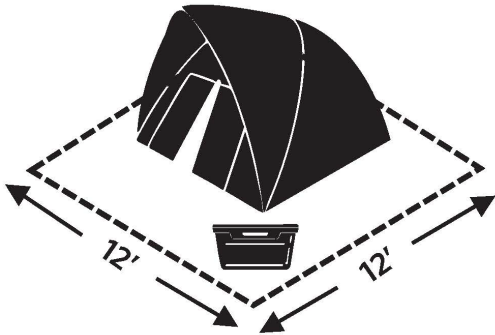

## ENCAMPMENT CONDITION GUIDELINES\*

Adhering to the guidelines will enhance the health and safety of you and your neighbors and help to protect the natural environment.

*\*NOTE: This handout provides a summary of the guidelines. Please refer to the full list of guidelines at [valleywater.org/encampments](http://valleywater.org/encampments) or request a copy from Valley Water staff.*



Keep your shelter and personal belongings in a 12'x12' area and keep food in closed containers



Do not build structures out of wood, metal, or other hard materials



No open fires



Pets must be kept under control and leashed; Dispose of pet waste



No loudspeakers or sound amplifiers; No other unreasonable noise disturbances



No possession or use of firearms, ammunition, or weapons



No illegal drug possession or distribution, or other criminal activities



No possession or use of fireworks or explosives



No threats or acts of violence



Do not trespass or dump debris on neighboring properties



No unauthorized vehicles



No dumping trash, debris, hazardous waste, or human or animal waste on Valley Water lands or in waterways



No digging, excavating, or terracing soil, or altering the natural environment



Keep all belongings off maintenance access roads, ramps, and trails



No tapping into electrical or water utility lines



Do not damage or remove vegetation, including trees



Do not capture fish or harm wildlife

### **SUBJECT:**

### **RECOMMENDATION:**

Receive information on the proposed Water Resources Encampment Inspection Report process and provide feedback, as necessary.

### **SUMMARY:**

On November 26, 2024, the Board adopted the Water Resources Protection Zones (WRPZ) Ordinance to address the environmental, health, and safety impacts of encampments on Valley Water property. The WRPZ Ordinance Implementation Plan (Plan) establishes criteria for classifying encampments as High Priority or Low Priority for cleanup or removal under the ordinance. The Plan includes Encampment Condition Guidelines to promote responsible camping practices and discourage harmful activities for encampments. Encampments that comply with these guidelines and do not obstruct Valley Water operations or maintenance will be designated as Low Priority. The Plan also introduces a progressive enforcement and education approach, allowing unsheltered individuals to learn about the guidelines and correct violations to avoid enforcement actions.

To align with the Plan's provisions, Valley Water is updating its encampment assessment approach. Since 2022, staff had utilized the Water Resources Encampment Risk Assessment tool as a standardized and transparent method for documenting and assessing encampments based on risk factors affecting Valley Water staff, facilities, environmental resources, and public safety (see Attachment 1). The risk assessment tool and process were considered by the ECCC in May 2022 and approved by the Board in August 2022. The assessment tool guides staff's determination of priorities for abatement and the process provides for Valley Water's CEO to approve staff's recommendations for abatement. Valley Water's Assistant CEO has since been delegated the authority to approve encampment removals conducted under the Risk Assessment. As part of ordinance implementation, staff has developed a proposed Water Resources Encampment Inspection Report (Inspection Report) (Attachment 2) to replace the Risk Assessment. Staff also created a Compliance Action Tag (Attachment 3) to inform unsheltered individuals of necessary

corrective actions if they are not present during staff inspections.

The attached Water Resources Encampment Inspection and Response Protocol (Attachment 4) provides a visual guide for the Inspection Report process. High Priority violations, as defined in the Plan, will trigger immediate enforcement. For Low Priority violations, individuals will receive education over multiple visits and have opportunities to correct issues. Like the prior Risk Assessment, the Inspection Report will standardize decision-making and enhance transparency.

Encampment cleanup or removal will be initiated if any High Priority violation occurs or is observed during any visit or if ongoing violations of the Encampment Condition Guidelines persist without significant progress toward compliance. Under the new procedures, encampment removals will be subject to final approval by Valley Water's Good Neighbor Program Assistant Officer, based on the Inspection Report.

**ENVIRONMENTAL JUSTICE AND EQUITY IMPACT:**

There are no environmental justice impacts associated with this item. However, Valley Water's WRPZ Ordinance Implementation Plan provides for a progressive enforcement and education approach, allowing vulnerable unsheltered individuals to correct violations to avoid enforcement actions under the ordinance.

### SUBJECT:

Review of Valley Water's Agreements and Collaborative Efforts for Unhoused Services.

### RECOMMENDATION:

Review Valley Water's agreements with the County of Santa Clara and the City of San José related to services for unhoused individuals and help identify proactive collaborative methods that can be pursued to collectively make meaningful progress with the unhoused living along the waterways in Santa Clara County.

### SUMMARY:

At the November 26, 2024, meeting, the Valley Water Board adopted the Water Resources Protection Zones (WRPZ) Ordinance. As part of the motion to adopt the ordinance, the Board referred to the Environmental Creek Cleanup Committee (ECCC) a review of existing agreements with the County of Santa Clara and the City of San José related to services for unhoused individuals to help identify proactive collaborative methods that can be pursued to collectively make meaningful progress with the unhoused living along the waterways in Santa Clara County.

### Current Agreements Related to Unhoused Services

#### *County of Santa Clara*

Since May 25, 2023, Valley Water has maintained an agreement with the County of Santa Clara Office of Supportive Housing (OSH) to provide funding for outreach and support services for unhoused individuals along waterways. Under this agreement, Valley Water provides up to \$200,000 annually to expand the County's outreach and coordination of human services to support encampments located on Valley Water owned land. The County's outreach teams focus on areas outside of the City of San José. Outreach services align with the Santa Clara County Continuum of Care Quality Assurance Standards and include housing needs assessments, temporary shelter referrals, and access to healthcare and behavioral health services in coordination with various County departments, such as Valley Homelessness Healthcare Program, the Public Health



Department, and the Behavioral Health Services Department. Valley Water and OSH are in discussions to extend this agreement and potentially expand its funding to cover Valley Water lands within the City of San José as well.

### *City of San José*

On April 21, 2023, Valley Water executed an agreement with the City of San José to resolve unhoused encampments to facilitate construction of the Coyote Creek Flood Protection Projects. This partnership is driven by the Federal Energy Regulatory Commission (FERC) order (February 20, 2020) requiring flood risk reduction measures related to the Anderson Dam Tunnel Project. The Coyote Creek Flood Management Measures Project and the Coyote Creek Flood Protection Project require the relocation of unhoused individuals to allow for project construction.

This agreement lays out existing related expenditures by each agency: the City of San José funds and manages outreach, supportive services, staffing, emergency/temporary housing, and other services at an estimated cost of \$9,329,655 and Valley Water provides public communication, labor and equipment for cleanup, ongoing maintenance, and security services at an estimated cost of \$4,685,081. Per the agreement, Valley Water is to reimburse the City up to \$4,844,414 for specific targeted services in furtherance of clearing the construction zone.

On May 6, 2019, Valley Water entered into an agreement with the City of San José to fund targeted patrols under SJPD's Stream Stewardship Law Enforcement (SSLE) program. These patrols aim to ensure the safety of Valley Water staff, volunteers, and the public along streams. The program includes up to three dedicated law enforcement teams that focus on specific stream segments identified by Valley Water. In addition to law enforcement duties, the City collaborates with the County and social service providers to offer outreach and support services to unhoused individuals living in encampments along waterways. On July 19, 2024, the agreement was renewed for a 12-month term with a not-to-exceed amount of \$340,000. Separately, Valley Water also provides funding at an hourly rate to San José Police Department (SJPD) via its Secondary Employment Unit to ensure staff safety during encampment cleanups.

### **Past Agreements Related to Unhoused Services**

Valley Water and the City of San José had maintained a Memorandum of Agreement (MOA) for Encampment Abatement, Trash Removal and Prevention since April 19, 2019, until it was terminated by the City on June 3, 2024. After rounds of negotiation, the parties did not reach agreement on a replacement MOA, but staff continue to collaborate on coordinated encampment cleanups as necessary. Valley Water and the City had entered into prior MOA's to partner on trash prevention and removal in 2004, 2008, and 2013.

### **Joint Powers Authority (JPA) Formation Request**

At the request of Board Vice Chair Santos, Valley Water issued a letter to the County of Santa Clara and all 15 cities within the County on February 28, 2025. This letter solicited interest in forming a JPA dedicated to addressing homelessness, encampments, and the increasing need for housing, shelter, and social services across Santa Clara County (Attachment 1).

**ENVIRONMENTAL JUSTICE AND EQUITY IMPACT:**

There are no environmental justice impacts associated with this item. However, Valley Water's effort to improve and expand its collaboration with local governmental agencies is intended to positively impact the vulnerable unsheltered community through better integration with the overall homelessness response in Santa Clara County.

Dear Esteemed Colleagues,

As we continue to face the growing and pressing issue of unsheltered homelessness in our community, I write to you today on behalf of the Santa Clara Valley Water District (Valley Water) Board of Directors to propose an idea that could help us address this challenge in a more coordinated and impactful way. Given the complexities of homelessness, I encourage local officials to explore the possibility of forming a county-wide Joint Powers Authority (JPA) focused on this issue. This could serve as a platform for representatives of our respective jurisdictions to collaborate and take collective, action-oriented steps toward meaningful solutions.

As we all know, homelessness in Santa Clara County, particularly unsheltered homelessness, has reached humanitarian, environmental, and public safety crises levels. While each of our jurisdictions has made significant strides in addressing this issue, the scale and scope of the problem requires an approach that transcends individual city or county efforts. We must collaborate in a more coordinated and effective manner to truly make progress.

The JPA could function similarly to the Los Angeles Homeless Services Authority (LAHSA), which was established in 1993 as a joint powers authority between the City and County of Los Angeles. LAHSA has proven to be an effective mechanism for the coordination of resources, policy development, and service delivery across a diverse and complex region. A JPA in Santa Clara County would bring together the expertise and resources of each of our jurisdictions, while providing a platform for accountability, shared decision-making, and innovation on the most pressing issues surrounding homelessness.

By leveraging the strengths and collective resources of each participating jurisdiction, we would be better positioned to develop and implement policies that help address the underlying causes of homelessness and provide comprehensive solutions. The JPA could focus on a variety of critical areas, including emergency shelter expansion, permanent supportive housing development, mental health and substance use disorder services, outreach strategies, and more. Through this collaboration, we can better serve the public, reduce duplication of efforts, and maximize our collective impact.

I am confident that by working together, we can make a meaningful difference in the lives of those experiencing homelessness in our community. Valley Water is happy to facilitate a joint discussion to explore this idea if there is interest. ### **SUBJECT:**

Receive information from the Youth Commission's Policy Writing Ad-Hoc Committee on the Proposed Plan to Address the Growing Concerns of Environmental Impacts in Relation to the Unhoused Population in Santa Clara County.

### **RECOMMENDATION:**

Receive information from the Youth Commission's Policy Writing Ad-Hoc Committee on the Proposed Plan to address the growing concerns of environmental impacts in relation to the unhoused population in Santa Clara County.

### **SUMMARY:**

The Valley Water Youth Commission is a Board Advisory Committee that consists of 21 high-school students throughout Santa Clara County. Each year, the Youth Commission develops a work plan that is approved by the Board.

In fiscal year 24 (FY24), the Youth Commission established the Policy Ad-Hoc Committee (Committee) to develop a proposal (Proposed Plan) with recommendations to address the growing concerns of environmental impacts in relation to the unhoused population in Santa Clara County.

On August 27, 2024, the Committee presented their Proposed Plan (Attachment 1) to the Board. The Board requested that the Proposed Plan be shared with the Environmental Creek Cleanup Committee for consideration.

Since then, the recommendations in the Proposed Plan have been evaluated and implemented, where applicable.

The Youth Commission developed an implementation project based on the Proposed Plan, called the Creekside Community Care Initiative (CCCI) Project. The CCCI Project was approved by the Board on November 12, 2024 as part of the Youth Commission's fiscal year 25 (FY25) work plan.

The CCCI Project implemented elements of recommendations 1.2 and 1.3 in the Proposed Plan,

---

including establishing community partnerships and providing resources to unhoused youth in Santa Clara County.

As part of the CCCI Project, the Youth Commission partnered with the Bill Wilson Center, a non-profit organization that provides services and resources to runaway and unhoused youth and families in Santa Clara County. The Youth Commission established a collection of hygiene items made of post-consumer recycled content and/or sustainable materials and assembled them into 100 hygiene kits, including a brochure on pollution prevention education and resources.

On February 23, 2025, the Youth Commission delivered the hygiene kits to the Bill Wilson Center for distribution to unhoused youth in Santa Clara County. The Commission also toured the Bill Wilson Center's drop-in facility, where they learned about the housing services and other resources the Bill Wilson Center provides for the unhoused community in Santa Clara County.

Recommendation 1.1 of the Proposed Plan focused on securing funding for safe sleeping sites on Valley Water land and supporting an established community land trust through financial contributions or land donations to promote affordable housing. While Valley Water's budget does not allow for directly financing housing projects or establishing a land trust, the agency is collaborating with external partners to develop interim housing and shelter solutions. Through a collaborative use agreement, Valley Water has partnered with the City of San José to provide land at Cherry Avenue for Emergency Interim Housing. Additionally, the City has evaluated four other Valley Water properties as potential safe sleeping sites. Staff continues to explore other opportunities for interim and permanent housing on underutilized parcels.

#### **ENVIRONMENTAL JUSTICE AND EQUITY IMPACT:**

The submission of this report on FY 25 activities under the Creekside Community Care Initiative Project by the Youth Commission is not subject to environmental justice analysis because it is unlikely to result in environmental or human health impacts. However, the work performed by the Youth Commission under this initiative aligns with Valley Water's values of fairness and equity and resulted in benefits for unhoused youth who received needed hygiene supplies kits through our partner agency.

**Message from Youth Commission Chair Emma Gao:**

As Chair of the 2023-24 Youth Commission, I sought to create a way for members of the Commission to voice their thoughts, in the form of policy, to the Board. In addition to the Commission's established work, I thought that a channel of direct communication with the Board was missing, especially in the form of new ideas that only the next generation can cultivate. With the valuable guidance of Valley Water staff, this year, a small group of Youth Commissioners took up this policy writing project that addresses the burgeoning problem of the environmental impacts of the unhoused population. The components of our three-part plan especially leverage our unique role as youth to contribute toward a solution to this complicated issue.

**Proposal Introduction & Purpose:**

The Valley Water Youth Commission Policy Writing Ad Hoc Committee consists of the following members: Samuel Alvarez, Emma Gao, Anika Kulkarni, Grace Liu, and Daphne Zhu. With the expanded authority to assist unsheltered people within Valley Water as granted by Assembly Bill 1469, we, the Policy Writing Ad Hoc Committee of the Valley Water Youth Commission, propose a three-part plan for the Board to adopt in order to address the environmental impacts of the unhoused population on Valley Water lands.

The first part of the proposal is establishing a plan to aid in resolving the houselessness issue within the county with concrete actions, such as a safe sleeping site on Valley Water land, and support towards certain policies by the Youth Commission; included with this is our strategy for acquiring funding for said projects. The second portion of the proposal involves outreach techniques and resources we hope to connect the unhoused population to while working with various nonprofits. The last part of the project is to conduct outreach to the public through existing channels within Valley Water. We hope that the Board will consider incorporating aspects of our proposal within their budget and work plan for next year.

**1.1: Build a coalition to garner support from various government agencies and foundations/non-profit organizations to provide additional funding and resources toward a land trust and an interim housing development.**

This proposal aims to create a collaborative effort to address the pressing housing crisis within our county. Our mission is to build a coalition comprising various government agencies, foundations, non-profit organizations, and youth groups to secure funding for a safe sleeping site and some funding towards a local community land trust.

Our strategy involves targeting key youth groups within our community to form a large body of youths aimed at the same mission; we plan to engage with entities including, but not limited to, the San Jose Youth Commission, Saratoga Youth Commission, the Allcove Youth Advisory Group, California Youth Connection, and numerous other groups, along with advocacy-focused school clubs. Upon joining the coalition, participating youth groups will be provided with immediate action plans, including signing petitions and endorsing our efforts. By collaborating with and gaining these groups' support, we aim to engage youth in our community, amplify our impact, and broaden our support base.



We recognize the power of the youth voice and hope to leverage our unique position in the county to secure funding for this project. We have identified several key agencies and foundations that align with our mission that we hope to reach out to for funding. These include, but are not limited to, the Sobrato Foundation, Chang-Zuckerberg Initiative, the City of San Jose Measure E Fund, Housing Trust Silicon Valley, Tipping Point Community, Silicon Valley Community Foundation, and Bay Area Community Foundation. To gather these organizations' support, we intend to organize presentations on behalf of the Valley Water Youth Commission, outlining the issue and our proposed solutions. Additionally, we will utilize flyers and social media infographics to raise awareness and rally support from the community, again hoping to leverage the community to bolster our financial resources for this project. In terms of fund allocation, we propose two primary avenues: investing in safe sleeping sites on Valley Water land and contributing to an already established community land trust within Valley Water's jurisdiction.

- A. Bill 1469 enables Valley Water to utilize its land for the construction of affordable and emergency housing facilities, which we propose can take the form of safe sleeping sites. Safe sleeping sites are a form of interim housing that places like Reno and San Diego have adopted. In March, Mayor Mahan suggested in his budget message that the City Manager work with Valley Water to get a site like this up and running. Our safe sleeping site could target those living along creeks, allowing Valley Water and other organizations to perform more extensive cleanings and lessen the pollution in these waterways. We are incentivized to use and support a program like this due to the fines the city of San Jose could face because of the polluted waterways. We can use this fact, along with the existing precedent and want, to leverage more support from local officials and groups. While safe sleeping sites only serve as a short-term solution, we believe it is the best course of action for Valley Water due to the low start-up costs and fast set-up times. This approach enables Valley Water to address issues of polluted waterways more quickly, and it paves the way for other wraparound services and the eventual development of long-term affordable housing.
- B. Bill 1469 also allows Valley Water to provide, sell, or lease land in the interest of housing development for unsheltered people. We propose that Valley Water contributes to an established community land trust, which operates as a nonprofit entity tasked with holding land for a specific community's benefit and providing various community assets such as affordable housing, green spaces, civic structures, and commercial areas. Specifically, we recommend partnering with the South Bay Community Land Trust, which focuses on housing development in Santa Clara County. By balancing the interests of its residents, the broader community, and public interests, land trusts ensure equitable wealth creation and preservation of communal resources, and they address the community's needs effectively. Through contributions to a land trust in the form of land or funding, Valley Water can promote permanent affordable housing in the county.

Our proposed housing development strategies encompass various approaches, including collaborating with community land trusts, advocating for inclusionary housing ordinances, exploring accessory dwelling unit (ADU) programs, and identifying underutilized land for development. Furthermore, we are committed to supporting long-term policy changes, such as Roadmap Home 2030. Moving forward, the Youth Commission would like to play a pivotal role in coordinating efforts with supporting youth groups, documenting their support, and engaging with organizations to secure funds. This will involve presenting project plans, submitting grant applications, and informing stakeholders of progress.

## **1.2: Develop partnerships with local nonprofits that aim to address various facets of homelessness under Valley Water jurisdiction.**

Partnerships with the following organizations will contribute to a reduction in the unhoused population, an increase in the services and dignity we could provide in a sleeping site, and aid in the reduction in the waste produced in encampments. Shortlisted are organizations with which collaborations and partnerships may be fruitful:

1. Downtown Streets Team, which seeks to end houselessness by restoring dignity and rebuilding the lives of unhoused persons to prepare them for permanent employment and housing.
  - a. The Downtown Streets Team works toward this goal by providing unhoused and low-income individuals with the opportunity to become Team Members and volunteer on beautification projects; in exchange, Team Members receive food and shelter and can use the organization's resources to find housing and employment.
  - b. An ideal partnership would include establishing joint operations with the Downtown Streets Team on creek stewardship and public art events, such as Valley Water's biannual cleanups and beautification projects.
2. We Hope, acts to provide clean water, meals, and housing for unhoused individuals.
  - a. We Hope aims to end homelessness, unemployment, and hunger through programs such as "Dignity on Wheels," through which they provide mobile showers and laundry devices to alleviate hygiene necessities.
  - b. An ideal partnership would include expanding the Dignity on Wheels program to Valley Water lands and the sleeping site, informing the unhoused community in the area of these resources through fliers and potentially staff.
3. Simplify the Basics provides hygiene products to the unhoused population, with over 2.5 million products distributed as of January 2024. Their goal is to help sustain the mental and physical health of people who are experiencing or at risk of houselessness. In addition to this, they also take great care in making sure that all their supplies are sustainable and environmentally friendly, which aligns with the goals of Valley Water.
  - a. An ideal partnership would include targeting areas on Valley Water lands to distribute hygiene products along with distributing said products in the new housing project proposed in 1.1. An extension may include aiding Simplify the Basics in supplying and distributing these environmentally friendly hygiene supplies with Valley Water employees and volunteers.

## **1.3: Raise awareness about the environmental impacts of encampments and solutions with the unhoused community and the public.**

By raising awareness about the environmental impacts of encampments we can garner more support for affordable housing development, and elevate this complicated aspect of the homelessness issue within the public consciousness; ultimately, we hope to spark dialogue around potential solutions and build more understanding for all parties involved. In particular, as members of the Youth Commission, we seek to target the middle and high school students in our communities. Although most youth may not yet have the power to directly address this topic, learning about it will nevertheless provide the next generation with a stronger understanding of the intersectionality of this issue.

To accomplish this objective, we first seek to identify existing outreach channels within Valley Water that we can build on to educate the general public. By utilizing Valley Water's existing [Education and Outreach Program](#), which includes School Classroom Programs, Library Programs, and Teacher

Resources, we can reach students within our target demographic. Moreover, we can incorporate this topic into the curriculum of the Water 101 Academy so that Water Ambassadors can tackle this issue during and after the duration of the course. Additional avenues include virtual, public discussion sessions as well as informational speaker sessions. This outreach will also support the greater network and coalition that we hope to build.

We also propose the continuation of existing efforts and collaborations regarding encampment cleanup and waste disposal. This includes expanding Valley Water's Good Neighbor Program and Environmental Cleanup Project if the budget allows. In addition to current updates on the website, Valley Water can provide further outlets of communication to the public on developments in this program by giving brief but regular updates in Valley Water's newsletter, as well as increasing the frequency of the published reports that are accessible on the website.

For each of these outreach opportunities, the Youth Commission, in partnership with Valley Water's outreach team, can develop a curriculum that covers information pertinent to this issue. The curriculum would include an explanation of the problem, the current solutions in place and their shortcomings, as well as insight into the perspective of the relevant parties, such as members of the unhoused community as well as Valley Water staff.

## **1.4: Conclusion & Next Steps**

### **1.4.1**

The organizations we provided can serve as a starting point for considering how Valley Water can collaborate with existing non-profit organizations to provide aid to the unhoused population in a way that will mitigate their environmental impact. We hope that the Board will consider allocating resources for this objective, potentially involving the Youth Commission in their efforts as well.

### **1.4.2**

By leveraging existing Valley Water resources, the provided means of outreach will require, in most cases, only an addition to a curriculum or presentation. The Youth Commission can also collaborate with outreach staff to develop these new materials.

### **1.4.3**

The immediate next steps involved for the Youth Commission include:

- 1.4.3.1 Contacting youth groups to inform them of the issue and gather their support
- 1.4.3.2 Formalizing a proposal to send to our sources of funding

The Youth Commission intends to move forward with this component of the proposal within their own timeline.
