Under the existing Pipeline Maintenance Program (PMP), Valley Water routinely inspects and maintains, repairs, and/or replaces pipelines and related appurtenances on the raw, treated and recycled water systems under their jurisdiction. The existing PMP has been successfully implemented since 2007; however, maintenance processes and tracking system technology in the pipeline related industry have been updated. To modernize the existing PMP and encompass and standardize all pipeline-related activities under a single program, Valley Water is developing an updated PMP EIR and an associated Program Manual.


