1. 2026 Central Valley Project Initial Allocation

On February 26, 2025, the U.S. Bureau of Reclamation (Reclamation) announced that the initial Central Valley Project (CVP) allocations for Agricultural contracts and Municipal and Industrial (M&I) contracts would be 15% and 65%, respectively. These CVP allocations correspond to approximately 90,000 acre-feet of supplies for Valley Water. The California Department of Water Resources (DWR) has maintained the State Water Project (SWP) allocation at 30%, which corresponds to 30,000 acre-feet of SWP supplies.

These allocations account for the average precipitation California has experienced in the start of the 2026 water year, Lake Shasta and Lake Oroville storage levels near the seasonal average, and a conservative assumption that the state will experience dry conditions for the rest of the water year. Additionally, statewide snowpack is below average, which has prevented further increases in allocation. Reclamation and DWR will continue to monitor precipitation and snowpack conditions throughout the winter and update the CVP and SWP allocations as additional information becomes available.

Approve Extension of Time to Develop SWP Permitted Water Supply

Problem Statement

The State Water Project (SWP) is seeking more time to develop the quantity of water contained in its existing water right permits. The Department of Water Resources (DWR), who owns and operates and holds the water rights for the SWP, filed a petition for a time extension with the State Water Resources Control Board (Water Board) approximately 15 years ago, but that application has never been processed.¹ The delay is hindering DWR's ability to modernize the SWP and plan for climate change.

The SWP is the nation's largest state-owned water and power generator and user-financed water system, and it plays a critical role in addressing climate change, helping California manage its water supply during extremes such as flood and drought.

The SWP has multiple water right permits. In California, water right permits contain a timeline for the development of water use that must be diligently pursued, and extensions of those timelines are regularly approved by the Water Board. DWR has been diligently pursuing the development of its SWP water rights. Over several decades DWR has constructed 36 water facilities, 21 pumping plants, five hydroelectric power plants, four pumping-generating plants, and approximately 700 miles of canals, tunnels, and pipelines. The SWP provides water to 27 million Californians and 750,000 acres of farmland throughout the state. The SWP provides water to 2/3 of Californians, including 3/4 of all our disadvantaged communities.

The State of California and the public water agencies who contract with DWR for SWP supplies, recently signed renewed water supply contracts effective through 2085 that obligate these agencies and their water rate payers to pay for the costs of the SWP, regardless of water delivered. Without the full development of the SWP water rights, rates are higher, water supply reliability is less certain, and the SWP becomes a stranded asset. Unfortunately, the full development of SWP's water rights has been hindered by circumstances outside of DWR's control, making a time extension necessary. Changes and significant delays in implementing environmental regulations have hindered DWR's permitting activities to support the full development of SWP water supplies for urban, municipal, and agricultural use. The SWP needs more time to permit and implement climate-responsive operations and infrastructure projects that are responsive to the 21st century climate conditions. Giving DWR more time to develop its already approved water rights addresses water availability and affordability for the vast majority of the state and is clearly in the public's interest.

SWP projects and planning activities that a time extension would support include, but are not limited to, the following:

¹ DWR's petition was continually on file with the Water Board except for a couple months in 2024 when the petition was pulled and refiled.

- Long-Term Operations Plans: Update the plan for the long-term operation of the SWP, including obtaining approvals from the state and federal governments. The plan must protect fish and wildlife using the best available science while also providing for more frequent use of existing SWP facilities, allowing greater fill and emptying of reservoirs and use of water diversion facilities in response to incoming storms, drought conditions, and other extremes that are now the new norm. Efforts could include use of Forecast-Informed Reservoir Operations using advanced weather forecasts to optimize water releases from Oroville Dam, reducing flood risks while storing more water safely, or real-time operations in the Delta when flows are exceptionally high and there is room in storage for the water without impacts to fish. These actions would provide additional climate resilience to the SWP supply, but could be limited without a time extension to implement them.
- North Bay Aqueduct (NBA) project: Add a new point of diversion and increase the capacity of the NBA, a crucial part of the SWP serving 500,000 residents in Napa and Solano counties. Unfortunately, the current NBA intake is not utilized to its full capacity due to its location where it is subject to poor source water, including high levels of total organic carbon, turbidity, and pathogens which are challenging to treat to water quality standards. The NBA is also capacity-limited. Construction of an alternative intake would address the challenges at the current location, increase its capacity, and allow for further development of DWR's existing water right for this facility. Without a time extension, DWR may not be able to pursue these important modifications.
- Increased South-of-Delta Storage: Develop up to 2 million-acre-feet of additional storage (above or below ground) to capture wet year surplus water for drought-year supplies. With extreme wet and dry conditions, it is more important than ever to have adequate storage space for water when it is abundant. Without a time extension, the ability to move and store water when it's wet for use when it's dry could be limited.
- Delta Conveyance Project: A modernized tunnel system to transport existing SWP water rights under the Delta, improving earthquake resilience and SWP's ability to capture water during high flow events. The DCP does not increase DWR's existing water right, but rather allows DWR to utilize its existing right. No other SWP action is more important for climate resiliency than the DCP.

Even if no infrastructure projects are ultimately approved, a time extension is necessary to modernize the system to more fully utilize existing SWP infrastructure in response to climate change as described above. SWP operations should be optimized to address climate change, with its predicted changes in flow patterns and timing of wet weather events.

Since this legislation would **not** approve any future project or change in SWP operations, the approval of the SWP time extension would not diminish the rights of members of the public to challenge future SWP permitting activities. The environment would be protected because future permitting processes would continue to be required before SWP operations could be changed and/or infrastructure projects built. None of the actions listed above or others that would allow DWR to develop its water right are

exempted from CEQA, NEPA, ESA, CESA or any other regulation protecting the environment, water quality, or water rights holders.

Legislative approval of the SWP time extension is appropriate because even if the SWP time extension petition were moved forward by the Water Board, the Water Board's administrative process would likely take years, cost the taxpayers hundreds of thousands of dollars in staff time, and water agencies significant time and money to just answer the question: was DWR diligent in pursuing the development of its full water right. The approval of the time extension has no negative environmental impacts, saves public funds, and does not diminish opportunities for public participation.

Proposed Legislative Solution

This legislation would extend the timeline for the full development of the SWP water permits to the year 2085, the same term as the existing, validated contracts for the SWP water supply.

This legislative proposal is consistent with the Governor's Executive Order N-16-15 (CA EO), January 31, 2025, which ordered the minimization of administrative obstacles to maximize water supplies. This legislative proposal implements this order without weakening environmental protection while protecting existing due process.

In accordance with the Santa Clara Valley Water District (Valley Water) Board Investment policy, staff provides a detailed investment report to the Board of Directors on a quarterly basis. In addition to the quarterly investment report, Government Code section 53607 requires the Treasurer of the local agency who has been delegated with the authority to invest funds to provide a monthly report of the investment transactions to the legislative body. This report is provided to the Board in compliance with Government Code section 53607 and Executive Limitation-4 Financial Management.

The report on investments as of January 31, 2026 is attached. All investments were in compliance with the Investment Policy. The attached report includes a summary of the portfolio holdings, details of each security in the portfolio and an investment activity summary with comparisons to the previous 12 months. The following are highlights of the investment activities for the month:

- The book value of Valley Water's portfolio as of January 31, 2026, was \$825 million. This represents an increase of approximately \$31 million compared to the book value as of December 31, 2025, due to the receipt of property taxes of \$76 million and payments of Water Utility and Watershed debt service of \$7 million and ~\$20 million for Imported Water.
- Valley Water's portfolio is invested with a primary goal of safety. To accomplish this goal, we only invest in securities that are permitted by the California Government Code and the Board Investment Policy. These securities have high credit ratings and maturities of no more than 5 years. As of January 31, 2026, approximately 58% of the portfolio was held in the US Government Treasury/Agency/Municipal Bonds, 38% was held in liquid funds (Local Area Investment Fund, Money Market mutual fund, and short-term deposits), and 4% in supranational/corporate medium-term notes.
- The portfolio had a yield-to-maturity of 3.6% for the month of January 2026. This is 0.46% below Valley Water's benchmark, the 24-month floating average of the 2-year Treasury note, which was 4.06%.
- Valley Water's portfolio is reviewed every month for compliance with the Investment Policy. All investments were in compliance for the reporting period.
- The California Government Code requires that a public entity structure its portfolio so that it, at minimum, can meet expenditures for the next six months. The investment portfolio has been structured to ensure that sufficient monies will be available to cover anticipated expenditure in the coming six months.

Community Bank Investments

Pursuant to Board direction and governance policies (Executive Limitation 4.7.7) regarding investments in small local banks and credit unions located within the nine Bay Area counties with total assets at or below \$10 billion (“community banks”), staff has expanded business with community banks, and limited business with large banks, as summarized below:

- Letters of Credit – Technology Credit Union, based in San Jose, provides three separate standby letters of credit totaling \$841,000 to Valley Water to meet the U.S. Army Corp’s financial assurance requirements for the operations of Upper Penitencia, Coyote Ridge, and Rancho Cañada de Pala Preserve watershed projects.
- Investments – Valley Water’s investment portfolio includes over \$65 million, or 8%, in deposits at community banks.
- Underwriting – Eight small investment banks located in California are included in Valley Water’s underwriting pool; four of these firms are veteran, minority or women owned.
- Large Bank Limitation - Valley Water only conducts business with large banks with total assets greater than \$10 billion that have satisfactory Environmental, Social and Governance (ESG) ratings provided by an independent professional rating firm.



Shiloh, Mike had tried to help me last year, and after I was denied, I didn't have the energy to fight the bureaucracy. There are two issues. One is the fence alongside the water district driveway, which was hit by one of the dozers they parked there for months. They denied it since I didn't have an exact date within 6 months. The construction was for 10 months. There are four sections or so where the nails are coming out after they hit it. I should have investigated when something came off the fence on our side but I didn't realize the cause.

The more critical one now is the rotting and decaying fence along the flood wall. It has been getting worse for years and they repeatedly took it out during construction and would stick pieces back in. They raised the level of the ground by over a foot without it ever being disclosed, This stopped allowing our drain to flow out. This drain was told to me by VW people to not be an issue with the wall yet I was not told the ground would be a foot higher. I dug my own hole back there so our yard would not flood. Now the rotting fence will rot faster since the bottom is subterranean. So many slats are out that our dog gets back there. The previous "fixes" have to keep adding a post behind our posts. I am considering just removing it and put in a dog fence from the flood wall to our neighbors rotting fence. Please let me know if you can help. My cell is [REDACTED]

To Lower Silver Creek Trail Advocates:

Thank you for your continued support of San José's trail network and the Lower Silver Creek Trail project. City staff would like to provide a brief update on our permitting

and easement efforts.

Permitting:

Due to some jurisdictional ambiguity along the corridor, the City prepared a Jurisdictional Delineation Report identifying the limits of potential waters of the U.S. and demonstrating that the proposed improvements can remain outside of federal jurisdiction. If the U.S. Army Corps of Engineers (USACE) concurs with the report, a full Section 404 design review may not be required.

The City is currently coordinating with the property owner, Valley Water, to obtain an encroachment permit in order to submit the delineation report to USACE for confirmation of federal jurisdiction. This coordination is nearing completion. Based on recent experience, a full Section 404 review can take up to two years to complete. By obtaining concurrence on the delineation report, we are hopeful this step will help streamline the overall project timeline.

Easement:

The preferred Lower Silver Creek Trail alignment along San Antonio Street requires acquisition of property owned by the Roman Catholic Diocese of San José. The Diocese has expressed hesitancy about granting public access across their property; however, they remain in active conversation with the City, and discussions are ongoing.

As with many trail projects, partnership with private property owners is essential to advancing implementation. Community support can play an important role in demonstrating the value of trail connectivity and the broader public benefits these projects provide.

For those interested in supporting this effort, continued community advocacy and expressions of support for the trail can help reinforce the importance of this connection. We will keep you informed as the submittal moves forward and may reach out should there be any additional opportunities for stakeholder support.
